Equititrust Limited (Receiver Appointed) (In Liquidation) (Receivers and Managers Appointed) A.C.N. 061 383 944 ("the Company")

I refer to my previous reports and provide an update on the Liquidation of the Company.

Investigations and Litigation

- On 23 July 2013, the Company's former Auditor delivered to the Court, 7 discs containing documentation relating to the audits conducted;
- Furthermore, the examinations were adjourned until 16, 17, 18 September 2013 and 8 October 2013.

Litigation Funding Deed

- I refer to the comments in my previous report with respect to the Litigation Funding Deed ("the Deed");
- Piper Alderman have made further amendments to the Deed, which I am currently reviewing;
- I expect that we will shortly be in a position to make an application to the Court to approve the Deed.

Asset and Liability Position

 I refer to the comments in my previous report with respect to the debt owed by Rosea Pty Limited and the delays on behalf of the borrower in fulfilling their obligations pursuant to the Deed of Settlement.

I am advised that a proposal has been submitted to the solicitors for the Court appointed Receiver, however despite requests that a copy be provided to this office, we are yet to receive a copy.

As such, I have instructed Thomsons Lawyers to issue correspondence to the solicitors for the Court appointed Receiver requesting that they provide details of the proposal, failing which an order will be made to the Court for injunctive relief.

 I have also engaged in an exchange of correspondence with the legal representatives acting for the National Australia Bank Limited ("NAB") in relation to their secured position, the debt owing to them and a proposal for a transfer of the remaining Bank Guarantees. I will provide further updates once they become available.
